**WAIVER (Under 18)**

Waiver, Indemnification and Release of Liability

In consideration of being allowed to participate in any way in the Collingwood Dragon Boat and Canoe Club (CDBCC) dragon boating and paddling programs and related events and activities, the undersigned, for him/herself, his/her personal representatives, heirs, next of kin:

1. Agrees that prior to participating, he/she will inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, he/she will immediately advise his/her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledges that he/she has been given an opportunity to review the CDBCC Rules and Regulations and Safety Guidelines (hereinafter the "Rules") and agrees to be bound and comply with the terms and provisions of the Rules.
3. Acknowledges and fully understands that paddling is a strenuous physical activity and that paddling and related activities involve risk of serious injury, including permanent disability and death resulting directly or indirectly in severe social and economic losses to person or property which may result from his/her own actions, inactions or negligence, the actions, inactions or negligence of others or the condition of the premises or equipment used. Further acknowledges and fully understands that there may be other risks not known or not reasonably foreseeable at this time.
4. Assumes all of the foregoing risks and accepts personal responsibility for any and all loss, liability, damages or costs whatsoever following any such injury, permanent disability or death however caused.
5. Releases, waives, discharges and covenants not to sue the CDBCC or affiliated clubs, the administrators, directors, agents, coaches, and other employees or agents, other club members or event participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of any premises used to conduct an event including the Corporation of the Town of Collingwood (hereinafter referred to collectively as the "Releasees") from any and all claims, actions, causes of action, liability, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused directly or indirectly by the negligence of the Releasees or otherwise.
6. Agrees to indemnify and save and hold harmless the Releasees from and against any claims, actions, causes of action, losses, liability, damages, or costs of any nature including legal fees they may incur due to the presence of the undersigned including competing, officiating, observing, volunteering or working at any paddling activity, function, or event.
